Improper application can be harmful to the switch, causing failure and possible injury or property damage. All use and installation must be in accordance with provisions of the National Electrical Code, and all applicable ASME codes, federal, state or local regulations and safety codes, and other applicable standards for mandated safety devices, which must be utilized independent of this switch, to provide safety protection. Installation or use not in accordance with these codes and standards could be hazardous to personnel and equipment.

A pressure switch being an electromechanical sensing device has parts which are subject to possible failure. **A pressure switch is not a safety device.** PSI is not responsible for loss or injury with other devices if used to function as a safety device.

Install unit where shock, vibration and ambient temperature fluctuations will not damage unit or affect operation. Normally the pressure switch can be mounted in any position. However, the unit should be installed so that moisture does not enter the enclosure through the conduit (tube). Applicable N.E.C. codes must be used with appropriate explosionproof sealing fitting when installing Series 6 switches.

**LIMITED WARRANTY OF PRODUCT:** PSI warrants that the product purchased is, upon delivery, free from defects or from faulty material or workmanship. It will be repaired or replaced by PSI within a period of time not to exceed 12 months from date of delivery to the buyer provided that an examination by the seller discloses that the defect is covered by this warranty. Any replacement or repair shall be done at PSI, Abita Springs, Louisiana. PSI must be notified prior to the return and shall be returned charges prepaid.
